**ORDINANCE CREATING THE TOWN OF LOS BAÑOS COMMUNITY-BASED
WOMEN AND CHILDREN'S DESK AT THE LOS BAÑOS POLICE STATION
PURSUANT TO R.A 8551**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS,
LAGUNA, in session assembled, THAT:

SECTION 1. Pursuant to Section 64, Creation and Function, Rule VII, Creation of
Women's Desks in all stations and the formulation of a Gender
Sensitivity Program, R.A.8551, Rules and Regulations Implementing
the PNP Reform and Reorganization Act of 1998.


"The PNP shall establish Women's Desk in all Police Station
throughout the country to administer and attend to cases involving
crimes against chastity, sexual harassment, abuses committed against
women and children and other similar offenses: Provided, that
municipalities and cities presently without policewomen will have
two (2) years upon the effectivity of Republic Act No. 8551 within
which to comply with the requirement of this Section."

SECTION 2. There is a need to establish a Community-Based Women Desk in the
Los Baños Municipal Police Station (LBMPS), Provincial Police
Office (PPO), PNP, NAPOLCOM and DILG.


SECTION 3. This ordinance shall take force and effect upon approval by the Sangguniang Bayan of Los Baños, Laguna.


