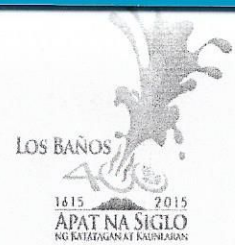

**RESOLUTION NO. 2015-142**

**RESOLUTION AUTHORIZING THE HONORABLE MAYOR CAESAR P. PEREZ TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE GRANTING OF SOCIAL PENSION TO ELIGIBLE INDIGENT SENIOR CITIZENS.**

WHEREAS, it is the responsibility of the state to promote the welfare and well-being of its people through prompt and effective provision of basic social services;

WHEREAS, this obligation clearly identified the senior citizens as one of the main target beneficiaries under Republic Act No. 9994, otherwise known as the Senior Citizens Act of 2010;

WHEREAS, the social pension is one of the social protection programs of the Department of Social Welfare and Development (DSWD) that provides FIVE HUNDRED PESOS (P500.00) monthly stipends for eligible indigent senior citizens which aims to help them in their basic needs such as medicines and food;

WHEREAS, qualified to receive the P500.00 monthly stipend are senior citizens who are frail, sickly, or have disabilities; are not receiving pension from Social Security System (SSS), Government Service Insurance System (GSIS), or Veterans Pension; and do not have a permanent source of income or regular support from relatives;

NOW THEREFORE, on motion of Councilor Antonio L. Kalaw, duly seconded by Councilors Norvin L. Tamisin and Julius A. Molinawe and approved by the councilors present;

RESOLVED, AS IT IS HEREBY RESOLVED, a resolution authorizing the Honorable Mayor Caesar P. Perez to enter and sign into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) for the granting of Social Pension to eligible indigent Senior Citizens.
